REGULAR MEETING:

<u>Budget – (IH) – TENTATIVE BUDGET FOR THE TOWN OF CLAY FOR THE</u> <u>YEAR 2022:</u>

An informational hearing to consider the **TENTATIVE BUDGET FOR THE TOWN OF CLAY FOR THE YEAR 2022**.

Supervisor Ulatowski began by reading the attached budget message. John Shehadi, Comptroller for the Town, gave a brief power point further explaining the 2022 Budget and the portions of the tax bill (see pie chart).

Nancy Kinnetz asked if funds have been allocated for improvements to the website and ultimately for virtual meetings. Councilor Pleskach explained that currently there are no local firms available for an overhaul to the website and that they plan to retry the proposal after 2022.

There was a discussion about a Facebook account for the Town of Clay; there are technical concerns and it is not a secure platform unless access is limited. Councilor Pleskach explained that we need to dramatically overhaul the Towns digital footprint.

Nancy Kinnetz also asked about the separation of duties mentioned in the audit. Supervisor Ulatowski said that he would review this.

There being no more comments or questions, Supervisor Ulatowski **closed** the public hearing.

LOCAL LAW NO. 1 OF THE YEAR 2021 TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW SECTION 3-C (PH):

TOWN OF CLAY 2022 BUDGET MESSAGE

The Tentative Budget for general and highway purposes totals \$16.8 million. As proposed, the tax rate for Town residents remains the same for the second consecutive year. Total spending is \$300,000 greater or .19% over the adopted budget for 2021. The increase includes necessary additions to contractual expenditures as well as employee salaries, wages & benefits.

The budget funds several Town maintenance projects which total \$117,000; \$20,000 is for the Highway Pole Barn roof, \$20,000 for siding at the Senior Center, \$77,000 for Improvements to Clay Park Central, Clay Park South and Meltzer Park.

The Town is continuing its effort to provide preventative road repair as a much less costly method for maintaining roads rather than waiting until costly reconstruction of the road surface is required. The 2022 budget includes a total appropriation for paving of \$2,300,000 which is targeted to keep on schedule with road maintenance as determined by the Cornell Road Condition Survey.

In 2019 the Town's Water Department embarked on a major project to install radio read capability for every water meter in the Uniform Water District at a cost of \$876,000 all of which was paid for with available funds of the Water District.

This project is expected to continue through 2021 and 2022. The new meters are giving the Water Department the ability to more efficiently capture consumption thus providing additional revenue. Installation is being performed by Water Department employees to minimize the overall cost.

The Town has been and will continue to be proactive in securing grant funding for various projects throughout Clay. The more recent grants totaling more than \$4.6 Million dollars include:

- All-inclusive Playground
- Central Park Restroom
- Project Green Education Center
- Three Rivers Brownfield Environmental Restoration Program
- Three Rivers Brownfield Opportunity Area
- Highway Street Sweeper
- Gaskin Road Repair Project
- Town-Wide Street Lighting Switchover to LED
